Dear T.A.A.F. Member:

T.A.A.F. Member cities have three options for their T.A.A.F. Member City membership for 2022:

Option #1 - TAAF Member City Dues -\$200.00

The current Member City dues of \$200.00 (this option will not change and will be available to any city)

Option #2 - TAAF Platinum Member City Dues -

This option will include the following:

- ❖ Member City Dues: **\$200.00**
- ❖ **February** – Hall of Fame & Winter meetings: one (1) night hotel and taxes – February 2022, Bryan, The Stella Hotel - Hall of Fame meal for 1 (Room -\$109.00 & Tax \$17.17=\$126.17 + 1- HOF banquet ticket-\$65.00)
Total \$ 191.17
- ❖ **April** – SMS University (Sports Management School) **registration for one (\$50.00)** & Mid-year meetings: **one (1) night hotel and taxes – April 25**, Courtyard Marriott New Braunfels, (Room \$139.00 +Tax \$18.07 =\$157.07)
Total \$ 207.07
- ❖ **September** – Annual Conference: **Three (3) nights hotel and taxes – September 12 13 15** meeting registration for one (1)-The Bevy Hotel, Boerne. (Room = Tax)=\$197.75 x 3=\$593.25+ Conference registration- \$225.00)
Total \$ 818.25

Option #2 can be invoiced in one payment - \$1,416.49; or in two payments: 10/10/21 – \$708.25; 5/1/22 - \$708.25

Note: Failure to use all room nights or registrations will NOT be refunded.
